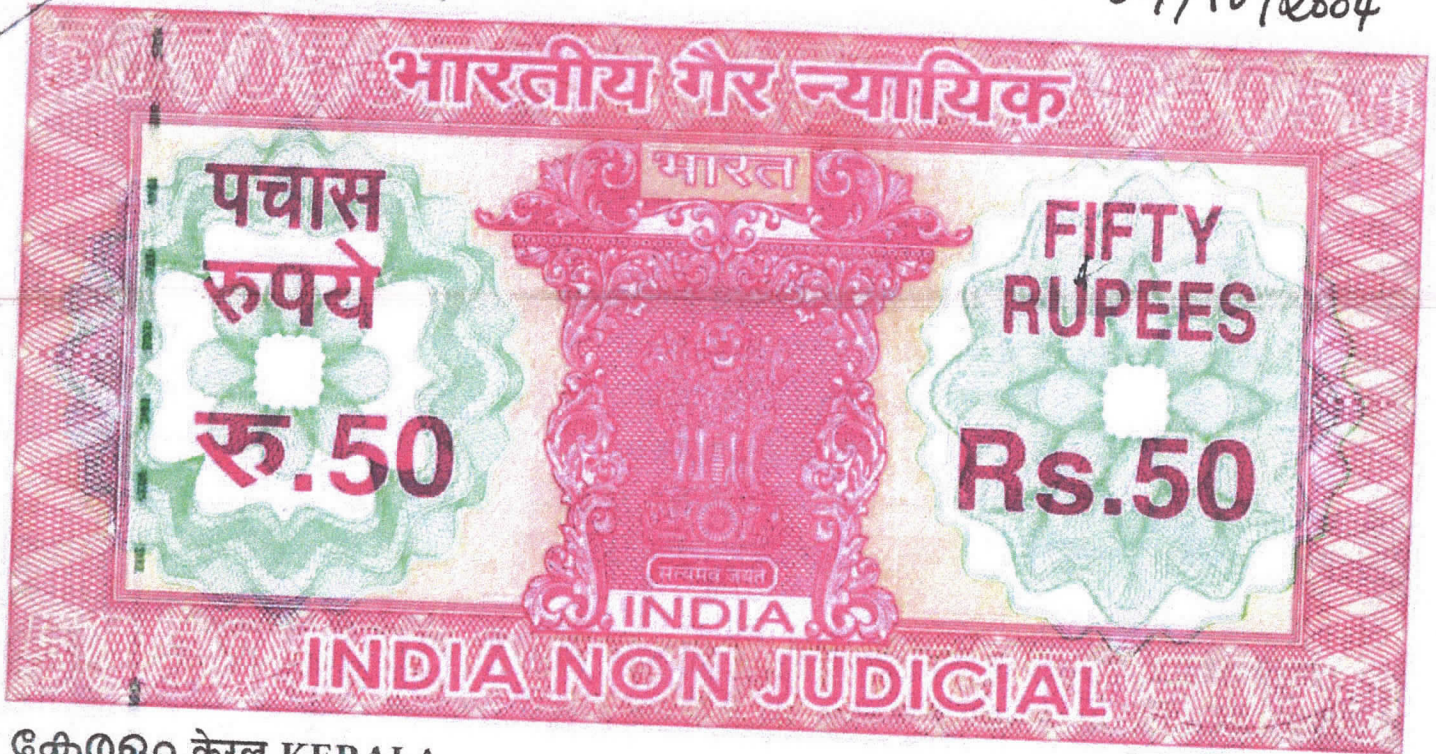

The Trust shall be for public charitable purpose and the words "Charitable purpose" mentioned herein shall have the meaning assigned to these words in section 2(15) of the Income Tax Act 1961. 3. OBJECT OF THE TRUST: The main objects of the trust are the educational, spiritual, social and cultural development, betterment, uplift and welfare of all the people in India. ----SULAIMAN KARADAN (Signed) -3- ----A. EDUCATION: a) To spread education in all fields and for achieving the said object to establish, maintain, run, develop and improve, extend, grant donations in cash and kind and assist in the establishment, maintenance, running, development, improvement, and extension of medical/technical universities medical/dental/technical colleges, nursing and/or other vocational institutions, dispensaries, hospitals, maternity homes, welfare centers of various nature, workshops, industrial and technical schools, and/or such other similar charitable institutions in India especially and including the socially and educationally backward district in the state or in India for the benefit and use of the general public. b) To establish, run support and grant aid or other financial assistance to Medical and/or other Technical universities, Medical, Dental and/or other ----SULAIMAN KARADAN (Signed) -4- ----Technical college, libraries, research and other institutions of the like nature in India for the use of students and staff, also for the development and advancement of Medical and/or other technical Education amongst the economically and socially backward classes of the society. c) To establish, maintain and run students, sponsorships, scholarships and render other kind of aid to students including supply of books

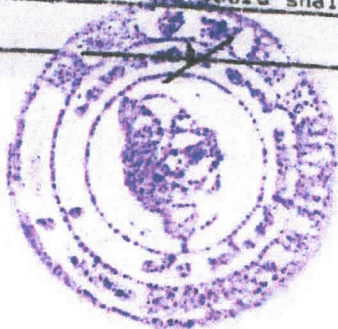
4. b) According to the circumstances and necessity of occasions as felt by the board, the Trust is empowered and authorised to enlarge its strength -----SULAIMAN KAPADAN (Signed) -7- -----by nominating members from outside as it feels necessary, subject to the condition that such nominations shall be supported by 2/3 of the total members of the trust. 5. DURATION OF THE BOARD: The board which I constitute and appoint hereby will be a permanent Board of Trustees and any vacancy in the Board occasioned by death, resignation, dismissal or otherwise shall be duly filled up by nominating members from outside by the remaining trustees, the nominees having been religious, honest and trust worthy, with a majority of 2/3 of the total members. 6. OFFICE OF THE TRUST: Office of the trust shall be at KUNIYA HOUSE, P.O. Periya, via. Pallikera, Kasargod District, Kerala state. The trust shall have an office at United Arab Emirates and the address shall be UNIVERSAL LUBRICANTS FACTORY L.L.C Post Box No. 6527 Sharjah UAE. The board shall have power to shift the office to any other part of Kerala or at UAE or open sub offices in such places as are deemed fit by the Board for the smooth functioning of the Trust. 7. FUNCTIONS OF THE BOARD: The Board of trustees shall govern, manage and administer the trust and trust properties to the best interest of the trust and its beneficiaries, discharge the duties with due care and ability and fulfill the purposes herein described with utmost sincerity. 8. POWERS OF THE BOARD: a) The Board shall appoint the necessary staff, employees and other officials for the functioning of the trust and shall have power to decide all matters relating to such appointments and other relevant factors in connection with the same. -----SULAIMAN KAPADAN (Signed) -8- -----b) The Board shall approve an annual budget for the ensuing financial year categorising the heads of income and expenditure. The financial year will be from April to March. c) The Board shall have power to accept the Trusteeships or managements of any other trusts or endowments and such trusts, or endowments shall be administered under the provisions of this deed in addition to any other agreeable directions made by the donor of such trusts or endowments. d) The board shall have power to acquire, accept or receive all endowments, gifts, grants, donations and any other contributions of any sort, movable or immovable made to this trust by individuals, groups, families, organisations or associations whether incorporated or not or by any Governmental state, Central or Foreign and all such endowments gifts, grants, donations and contributions would be considered as part

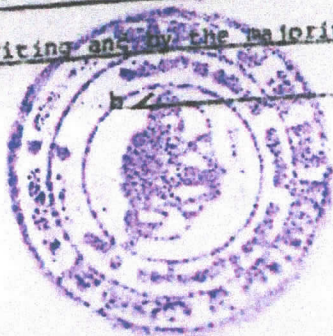
of this trust properties and their managements. income and expenditure shall be unconditionally carried on as per the provisions of this deed. e) The Board shall not have the power to sell the properties of the trust or any part thereof except in cases of unavoidable necessity and circumstances for purchasing more beneficial properties, movable or immovable, and no such sale or transfer of the trust property shall be made by the trustees without the prior sanction of the chairman. But the Board shall have the power to pawn, pledge mortgage or lease the board properties to borrow and to raise funds and loans for the purposes of the Trust and no such sale, pawn, pledge or mortgage or lease shall be valid unless made after the decisions of the board by 2/3 -----SULAIMAN KARADAN (Signed) -9- -----majority of its existing strength and all such transactions and purchase shall be made in the name of the chairman of the trust. f) The board shall deposit the funds of the trust in such bank or banks as is or are decided by the board in the name of the trust and unless and until otherwise decided by the board the chairman and secretary of the board shall have power to negotiate and operate jointly on such bank accounts by issuing joint signed cheques or bills and drawing amounts more than the annual budgetary estimate without the special sanction of the Board. 9. The trustees, if and when deemed fit by them, may delegate their responsibility, rights and powers as defined in the clause of this deed (by a 2/3 majority of its total strength) to execute committee elected from among them of not more than six members including a chairman and secretary and headed by the chairman of this trust. The Board of trustees shall have the right to suspend or terminated the said execute committee at any time of their choice by the same majority. 10. The trustees if and when deemed fit by them, may delegate their responsibility, rights and powers as defined in the clauses of this deed (by 2/3 majority of its total strength) to execute committee elected from among them of not more than six members including a chairman and secretary and headed by the chairman of this trust. The board of trustees shall have the right to suspend or terminate the said executive committee at any time of their choice by the same majority. 11. PROMOTERS: The chairman of the trust may nominate as promoters of the trust, those persons who take a keen and abiding interest to the establishment and working of the trust. A meeting of such promoters will be held at least once in every financial year and their suggestions regarding the activities of the trust will be ascertained. -----SULAIMAN KARADAN (Signed) -10- -----12. CHAIRMAN OF THE BOARD: I hereby appoint Ibrahim Ahmed Ali as the chairman of the trust for life or until I resigns whichever happens earlier and after that the board shall elect one among its members as the

Chairman who will hold office for five years thereafter leaving the post for new elections, there being no bar for the vacated chairman for re-election. 13. POWERS AND FUNCTIONS OF THE CHAIRMAN: 1. The chairman will preside over the board meetings, supervise the functioning of the trust and give necessary directions to the proper administration of the board. 2. The chairman shall represent the board in all actions, civil, criminal and revenue and in all offices of the Government, Central, State or foreign, including income tax, and sales tax offices and before all or any appellate authorities of such offices, unless and until decided otherwise by the board. 3. The chairman shall have full powers over the assets and funds of the trust and shall have full control over the management of funds and other financial activities of the trust. 4. Notwithstanding the powers of the Board in appointment of trustees and members of the trust as per clause 8(a) the chairman shall have an additional power to appoint or remove any of the trust member from the trust or Board if it finds necessary for him to do so even without the prior consent of the Board of trustees. Such appointments or removals made by him shall not be questioned by the Board. 5. The chairman shall have the power to acquire, sell, transfer, ^{5.} ~~pledge~~ ^(pledge) mortgage or lease any of the properties of the trust at any time if it so expedient for him to do so in the interest of the trust even without the prior sanction of the Board of trustees. ----- SULAIMAN KARADAN (Signed) - 11 ----- 6. The decision making authority in all matters connected with the trust shall be vested with the chairman. 14. CASTING VOTE OF CHAIRMAN: Where the members of the board in session is equally divided in voting, the chairman will have the right of casting vote and the finality of the matter in dispute will be ^{7.} ~~decided~~ ^(decided) accordingly. 15. SECRETARY: In view of the convenient management of the trust the board there shall be a secretary of the trust who shall be appointed for a period of three years on honorary basis and the secretary so appointed shall perform the day to day administration and management of the trust including the preparation of the annual budget and his functions referred to in clause 8 (f). The Board can decide to allow such allowances or honorarium, data or grant to the secretary according to circumstances. The secretary shall not kept it hand an amount more than Rs. 10,000/- (Rupees Ten thousand only) 16. SITTING OF BOARD: The board shall sit in session atleast once in every month. The secretary shall submit before the board in every sitting the working report of the trust and the budget for the next year in the primary session of the year. 17. QUORUM AND MAJORITY: The quorum of the board shall be 4/3 in number excluding the chairman and all the decisions of the board shall be in writing and by the majority of the members present. The major

any decision of the board shall not be questioned by any member of the board. But the board will have its discretion to review its own decisions. In case one meeting of the board is occasioned to be postponed for want of quorum the second meeting shall be conducted with the trustees present, irrespective of quorum. The minutes of every trust meeting shall be recorded in the minutes book and is to be signed by the chairman which shall thereafter be treated as an evidence that the proceedings of that meeting were passed. ----SULAIMAN KARADAN(Signed) -12- ----18. Any trustee or trustees whose act or/and behaviour are found detrimental to the interests of this trust may be dismissed by the board by a resolution approved by the majority of 2/3 of the total strength of the board. 19. AUDITING: The accounts of the trust may be audited by a chartered Accountant or otherwise duly qualified auditor. 20. LEGAL ADVISOR: The board may at any time appoint a legal advisor to the board and the monthly or annual remuneration traveling allowance, bata etc. of the legal advisor shall be fixed by the board and the board shall have the power to terminate the services of the legal advisor at any time within one months notice. 21. All institutions run and managed by the trust and its committees being managed by the majority committee, are eligible to get protection envisaged in Article 31 of the Indian constitution. 22. ACT APPLICABLE: That the trust is to be governed by the provisions of the Indian Trust Act (Act II of 1982) 23. IRREVOCABILITY: This trust is an irrevocable trust and neither me nor my descendants have any right or authority to revoke it. 24. REGULATIONS: By a majority of 2/3 of the trustees, the board shall have power to frame regulations, helpful and ameliorative to the conduct and running of the trust but the regulations so framed shall be in no case be derogative or circumventing the directions of this deed. 24. AMENDMENT OF RULES AND REGULATIONS: The rules and regulations of the trust may be amended or altered after obtaining approval by 2/3 of the members present and as may be necessary from the Commissioner of Income-Tax or such other appropriate authority under the ----SULAIMAN KARADAN(Signed) -13- ----law for the time being in force and any amendment or alteration so made shall be deemed to form part of the original trust deed. 25. VALUATION: The trust properties are valued at Rs. 5000/- (Rupees five thousand only) 26. CESSION: In the event of cessation of the trust the same shall be merged with other trusts having same and/or similar objects or with central Government.
